**ORDER TO SHOW CAUSE WHY COURT SHOULD NOT GRANT  
MOTION FOR FINAL DEFAULT JUDGMENT**

THIS CAUSE is before the Court upon Plaintiff's Motion for Entry of Final Judgment by Default as to Certain Defendants (the "Motion") [DE 59], filed herein on January 16, 2024. The Court has carefully considered the Motion [DE 59] and is otherwise fully advised in the premises.


Plaintiff filed a Complaint on October 17, 2023. *See* [DE 1]. Defendants were served on December 7, 2023. *See* [DE 32]. As of the date of this Order, Defendants have not responded to the Complaint. On January 12, 2024, the Clerk entered a default against Defendants, the Individuals, Business Entities, or Unincorporated Associations identified on Schedule "A" to Plaintiff's instant Motion (collectively "Defendants") for failure to appear, answer or otherwise plead to the complaint filed herein within the time required. *See* [DE 15]. Thereafter, on January 11, 2024, Plaintiff filed the instant Motion [DE 57] seeking a default judgment against certain

Defendants identified on Schedule “A” to the Complaint numbered 1-12, 14-20, 22-26, 30-34, 36-38, 40-42, 44-491 (“Defaulting Defendants”).<sup>1</sup>

Accordingly, it is **ORDERED AND ADJUDGED** as follows:

1. Defaulting Defendants shall show cause on or before **January 30, 2024**, why the Motion [DE 59] should not be granted. A failure to timely respond will result in the immediate entry of a default judgment against Defaulting Defendants.
2. Plaintiff is ordered to serve a copy of this Order upon Defendants and to file a notice of compliance in the record.

<sup>1</sup> Plaintiff states that he has not yet moved or default judgment as to Defendants 13 and 43 because those Defendants are currently in good faith negotiations with Plaintiff. *See* [DE 59] at p. 1. The Court will require Plaintiff to either file a motion for default judgment as to Defendants 13 and 43 or to file a voluntary dismissal as to Defendants 13 and 43 on or before **January 31, 2023**. Defendants 27-29, and 39 have been dismissed). And the January 26, 2024 deadline for Defendant 35 to respond to the Complaint has not yet passed. *See* [DE 54].
