PLAINTIFF'S MOTION FOR ENTRY OF CLERK'S DEFAULT

Plaintiff Shenzhen Dejiayun Network Technology Co., Ltd. ("Plaintiff" or "Dejiayun"), by and through its undersigned counsel, hereby requests that the Clerk enter default in this matter pursuant to Fed.R.Civ.P. 55(a) against certain Defendants identified in the Schedule A (D.E. 8-2) of the Complaint, specifically absuyy LLC, Allatever, BARBARIZAT, Bnwani Store, BTJXX STORE, CFox Co.ltd, Cryptic, CSun Co.ltd, DEITY, EAGLE, FS MALL, Get rich, Good friend store, GUANG ZHOU SHI MA LONG JING MAO YOU XIAN Co.ltd, Guyueyu Co.,ltd, Happy Mall, HOMEDLES Co.Ltd, Hundred Treasure Bag, LBYUINBG, LEMON-NM, LUNE, meituanyouxuan, Ornament Co.Ltd, Passion Co.ltd, Philosophical research, Pro Seller, Prominence store, Ricardo M. Lu, Sayuri, shenzhenhuangtianye, shenzhenshijingrumeng, shenzhenshixiaoliyudianzi, Sixteen Store, Sunton, Sweetheart Island, Tr.CAT CHr MALL, Wisdooom Green Industrial Trade Inc, Xiaoxin Store, YOOUK, and Yoursss ("Defaulting

Defendants”) on the grounds that Defaulting Defendants have failed to appear or otherwise respond to the Complaint within the time prescribed by the Federal Rules of Civil Procedure.

1. On January 30, 2024, Defaulting Defendants were served with the Summons and a copy of the Complaint by email communication as authorized by this Court’s Order on Alternate Service. (D.E. 21, 32).

2. The time allowed for Defendants to respond to the Complaint has expired. Neither Plaintiff nor the Court has granted Defendants an extension of time to respond to the Complaint. Defendants have failed to answer or otherwise respond to the Complaint, or serve a copy of any Answer or other response upon Plaintiff's attorney of record.

3. Plaintiff is informed and believes that Defendants are not considered infants or incompetent persons. Plaintiff is informed and believes that the Service Members Civil Relief Act does not apply.

WHEREFORE, Plaintiff Dejiayun requests that the Clerk enter default, as authorized by Fed.R.Civ.P. 55(a) against the Defaulting Defendants.
