Harjani: Before the Court is plaintiff's motion [64] for entry of default and default judgment against all remaining defendants: bodhi1998 (No. 73), bigbigshow2012 (No. 74), broadfashion (No. 76), wishmart2014 (No. 110), and VISLAND (No. 140). All remaining defendants have failed to respond to the Complaint in the time allowed. See Doc. 61. Accordingly, an order of default is entered under Rule 55(a) of the Federal Rules of Civil Procedure. Any objections to the motion for entry of default judgment must be filed on or before 6/11/2024. If no objections are filed by that date, the Court will consider the motion unopposed. The Court will also rule on the papers unless a hearing is requested by 6/11/2024. A hearing, to be conducted via teleconferencing, may be requested by filing a Request for Hearing as a separate entry on the docket. Plaintiff must serve this minute order upon all remaining defendants within one business day of its entry on the docket and must promptly file proof of that service. A tentative default judgment hearing is set for 6/18/2024 at 9:15 a.m. Telephone status hearing set for 6/5/2024 is stricken.
