**DEFAULT JUDGMENT
ORDER**

This action having been commenced by Plaintiff Lei Tang (“Plaintiff” or “Tang” hereinafter) against the Defendants identified on the Amended Schedule “A”, and using the Defendant Domain Names and Online Marketplace Accounts identified on the Amended Schedule “A” (collectively, the “Defendant Internet Stores”), and Plaintiff having moved for entry of Default and Default Judgment against the Defendants identified on the Amended Schedule “A” Numbered 1-27, 29-34, 36, 37, 39-69, 71, 73, 77-84, 86-88, 90-94, 97-99, 100-104, 106-109, 111-115, 117-139, 141-177 and attached hereto which have not yet been dismissed from this case (collectively, “Defaulting Defendants”);

This Court having entered a preliminary injunction; Plaintiff having properly completed service of process on Defaulting Defendants, the combination of providing notice via electronic publication and e-mail, along with any notice that Defaulting Defendants received from domain name registrars and payment processors, being notice reasonably calculated under all circumstances to apprise Defaulting Defendants of the pendency of the action and affording

them the opportunity to answer and present their objections; and none of the Defaulting Defendants having answered¹, and the time for answering having expired, so that the allegations of the Complaint are uncontroverted and are deemed admitted;

This Court finds that it has personal jurisdiction over Defaulting Defendants because Defaulting Defendants directly target their business activities toward consumers in the United States, including Illinois. Specifically, Plaintiff has provided a basis to conclude that Defaulting Defendants have targeted sales to Illinois residents by setting up and operating e-commerce stores that target United States consumers using one or more seller aliases, offer shipping to the United States, including Illinois, and have sold products using infringing and counterfeit versions of Plaintiff's federally registered copyrights (the "Tang Works") to residents of Illinois. In this case, Plaintiff has presented screenshot evidence that each Defendant e-commerce store is reaching out to do business with Illinois residents by operating one or more commercial, interactive internet stores through which Illinois residents can and do purchase products using counterfeit versions of the Lei Tang copyright images. *See* Docket No. 6, which includes screenshot evidence confirming that each Defendant e-commerce store does stand ready, willing and able to ship its counterfeit goods to customers in Illinois bearing infringing and/or counterfeit versions of the Lei Tang copyrights.

The relevant samples of the Tang Works are included below.

¹ Of the Defaulting Defendants, only Defendants qb.studio (100) and thatkey (106) filed appearances. They were granted an extension of time to answer or otherwise plead by 03/25/2024, but no responsive pleadings have been filed.

This Court further finds that Defaulting Defendants are liable for willful federal copyright infringement (17 U.S.C §101 510 *et seq.*).

Accordingly, this Court orders that Plaintiff’s Motion for Entry of Default and Default Judgment is GRANTED as follows, that Defaulting Defendants are deemed in default, and that this Default Judgment is entered against Defaulting Defendants.

This Court further orders that:

1. Defaulting Defendants, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under, or in active concert with them be

permanently enjoined and restrained from:

- a. using the Tang Works or any reproductions, counterfeit copies, or colorable imitations in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not a genuine Lei Tang product or not authorized by Lei Tang to be sold in connection with the Tang Works;
 - b. passing off, inducing, or enabling others to sell or pass off any product as a genuine Lei Tang product or any other product produced by Lei Tang that is not Lei Tang's or not produced under the authorization, control, or supervision of Lei Tang and approved by Lei Tang for sale under the Tang Works; committing any acts calculated to cause consumers to believe that Defaulting Defendants' products are those sold under the authorization, control, or supervision of Lei Tang or are sponsored by, approved by, or otherwise connected with Lei Tang; and
 - c. manufacturing, shipping, delivering, holding for sale, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for Lei Tang, nor authorized by Lei Tang to be sold or offered for sale, and which bear any of Tang Works, including any reproduction, counterfeit copies or colorable imitations.
2. The domain name registries for the Defendant Domain Names, including, but not limited to, VeriSign, Inc., Neustar, Inc., Afilias Limited, CentralNic, Nominet, and the Public Interest Registry, and the domain name registrars, including, but not limited to, GoDaddy Operating Company LLC, Name.com, PDR LTD. d/b/a/ PublicDomainRegistry.com, and Namecheap Inc., within seven (7) calendar days of

receipt of this Order, shall, at Lei Tang's choosing:

- a. transfer the Defendant Domain Names to Lei Tang's control, including unlocking and changing the registrar of record for the Defendant Domain Names to a registrar of Lei Tang's selection, and the domain name registrars shall take any steps necessary to transfer the Defendant Domain Names to a registrar of Lei Tang's selection; or
 - b. disable the Defendant Domain Names and make them inactive and untransferable.
3. Defaulting Defendants and any third party with actual notice of this Order who is providing services for any of the Defaulting Defendants, or in connection with any of the Defaulting Defendants' Online Marketplaces, including, without limitation, any online marketplace platforms including but not limited to Amazon.com, ebay, AliExpress, AliPay, Individual Sites, Joom, Sears, temu, Paypal, Walmart, Wish and Lianlian (collectively, the "Third Party Providers"), shall be served electronically with this Order and within seven (7) calendar days of receipt of this Order cease:
- a. using, linking to, transferring, selling, exercising control over, or otherwise owning the Online Marketplace Accounts, or any other online marketplace account that is being used to sell or is the means by which Defaulting Defendants could continue to sell counterfeit and infringing goods using the Tang Works; and
 - b. operating and/or hosting websites that are involved with the distribution, marketing, advertising, offering for sale, or sale of any product bearing the Tang Works or any reproductions, counterfeit copies or colorable imitations thereof that is not a genuine Lei Tang product or not authorized by Lei Tang to be sold

in connection with the Tang Works.

4. Upon Lei Tang's request, those with notice of this Order, including the Third Party Providers as defined in Paragraph 4, shall within seven (7) calendar days after receipt of such notice, disable and cease displaying any advertisements used by or associated with Defaulting Defendants in connection with the sale of counterfeit and infringing goods using the Tang Works.
5. Pursuant to 15 U.S.C. § 1117(c)(2), Lei Tang is awarded statutory damages from each of the Defaulting Defendants in the amount of one hundred thousand dollars (\$100,000) per Defaulting Defendant pursuant to 15 U.S.C. § 1117(c) and one hundred thousand dollars (\$100,000) for willful infringement pursuant to 17 U.S.C. § 504(c). This award shall apply to each distinct Defaulting Defendant only once, even if they are listed under multiple different aliases in the Complaint and Amended Schedule A.
6. Any Third Party Providers holding funds for Defaulting Defendants, including but not limited to Amazon.com, ebay, AliExpress, AliPay, Individual Sites, Joom, Sears, temu, Paypal, Walmart, Wish and Lianlian, shall, within seven (7) calendar days of receipt of this Order, permanently restrain and enjoin any accounts connected to Defaulting Defendants or the Defendant Internet Stores from transferring or disposing of any funds (up to the statutory damages awarded in Paragraph 6 above) or other of Defaulting Defendants' assets.
7. All monies (up to the amount of the statutory damages awarded in Paragraph 6 above) currently restrained in Defaulting Defendants' financial accounts, including monies held by Third Party Providers including but not limited to Amazon.com, ebay, AliExpress, AliPay, Individual Sites, Joom, Sears, temu, Paypal, Walmart, Wish and

Lianlian, are hereby released to Lei Tang as partial payment of the above- identified damages, and Third Party Providers, including PayPal, and Amazon Pay, are ordered to release to Lei Tang the amounts from Defaulting Defendants' financial accounts within fourteen (14) calendar days of receipt of this Order.

8. Until Lei Tang has recovered full payment of monies owed to it by any Defaulting Defendant, Lei Tang shall have the ongoing authority to commence supplemental proceedings under Federal Rule of Civil Procedure 69.
9. In the event that Lei Tang identifies any additional online marketplace accounts or financial accounts owned by Defaulting Defendants, Lei Tang may send notice of any supplemental proceeding, including a citation to discover assets, to Defaulting Defendants by e-mail at the e-mail addresses for Defendants identified in Exhibit [6-3] to the Declaration of Lei Tang and any e-mail addresses provided for Defaulting Defendants by third parties.
10. To obtain release of the bond previously posted in this action, Plaintiff's counsel must file a motion for the return of the bond once the preliminary injunction no longer applies to any defendant.

This is a Default Judgment.
