DEFAULT JUDGMENT ORDER

This action having been commenced by Plaintiff Collectanea J. Limited ("Collectanea ") against the defendants identified on Schedule A, and using the Defendant Domain Names and Online Marketplace Accounts identified on Schedule A (collectively, the "Defendant Internet Stores"), and Collectanea having moved for entry of Default and Default Judgment against the defendants identified on Schedule A attached hereto which have not yet been dismissed from this case (collectively, "Defaulting Defendants");

This Court having entered a preliminary injunction; Collectanea having properly completed service of process on Defaulting Defendants, the combination of providing notice via electronic publication and e-mail, along with any notice that Defaulting Defendants received from domain name registrars and payment processors, being notice reasonably calculated under all circumstances to apprise Defaulting Defendants of the pendency of the action and affording them the opportunity to answer and present their objections; and

None of the Defaulting Defendants having answered or appeared in any way, and the time for answering having expired, so that the allegations of the Complaint are uncontroverted and are deemed admitted;

This Court finds that it has personal jurisdiction over Defaulting Defendants because Defaulting Defendants directly target their business activities toward consumers in the United States, including Illinois. Specifically, Collectanea has provided a basis to conclude that Defaulting Defendants have targeted sales to Illinois residents by setting up and operating e-commerce stores that target United States consumers using one or more seller aliases, offer shipping to the United States, including Illinois, and have displayed, marketed, or advertised with Collectanea’s federally registered copyrights (the “Beadnova Works”) to residents of Illinois. In this case, Collectanea has presented screenshot evidence that each Defendant e-commerce store is reaching out to do business with Illinois residents by operating one or more commercial, interactive internet stores through which Illinois residents can and do purchase products from listings for sale using the Beadnova Works without authorization, *See* Docket No. [9], which includes screenshot evidence confirming that each Defendant e-commerce store does stand ready, willing and able to ship its goods to customers in Illinois.

This Court further finds that Defaulting Defendants are liable for willful copyright infringement.

Accordingly, this Court orders that Collectanea's Motion for Entry of Default and Default Judgment is GRANTED as follows, that Defaulting Defendants are deemed in default, and that this Default Judgment is entered against Defaulting Defendants.

This Court further orders that:

1. Defaulting Defendants, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under, or in active concert with them be permanently enjoined and restrained from:
 - a. using the Collectanea Copyrights or any reproductions, copies, or colorable imitations in any display, marketing, advertising, or offering for sale;
 - b. committing any acts calculated to cause consumers to believe that Defaulting Defendants' products are those sold under the authorization, control, or supervision of Collectanea, or are sponsored by, approved by, or otherwise connected with Collectanea
2. The domain name registries for the Defendant Domain Names, including, but not limited to, VeriSign, Inc., Neustar, Inc., Afilias Limited, CentralNic, Nominet, and the Public Interest Registry, and the domain name registrars, including, but not limited to, GoDaddy Operating Company LLC, Name.com, PDR LTD. d/b/a/ PublicDomainRegistry.com, and Namecheap Inc., within seven (7) calendar days of receipt of this Order, shall, at Collectanea's choosing:
 - a. transfer the Defendant Domain Names to Collectanea's control, including unlocking and changing the registrar of record for the Defendant Domain Names to a registrar of Collectanea's selection, and the domain name registrars shall take any steps necessary to transfer the Defendant Domain Names to a registrar of Collectanea's selection; or

- b. disable the Defendant Domain Names and make them inactive and untransferable.
3. Defaulting Defendants and any third party with actual notice of this Order who is providing services for any of the Defaulting Defendants, or in connection with any of the Defaulting Defendants' Online Marketplaces, including, without limitation, any online marketplace platforms such as Amazon, eBay, Inc., AliExpress, Alibaba Group Holding Ltd. ("Alibaba"), DHGate, etsy, Walmart, Paypal, Payoneer, PingPong, Stripe, LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. ("LianLian") (collectively, the "Third Party Providers"), shall within seven (7) calendar days of receipt of this Order cease:
 - a. using, linking to, transferring, selling, exercising control over, or otherwise owning the Online Marketplace Accounts, or any other online marketplace account that is being used to sell or is the means by which Defaulting Defendants could continue to display, advertise or market using the Collectanea Copyrights; and
 - b. operating and/or hosting websites that are involved with the marketing, advertising, offering for sale, or display of the Collectanea Copyrights or any reproductions, copies or colorable imitations thereof that is not not authorized by Collectanea.
4. Upon Collectanea's request, those with notice of this Order, including the Third Party Providers as defined in Paragraph 3, shall within seven (7) calendar days after receipt of such notice, disable and cease displaying any advertisements used by or associated with Defaulting Defendants in connection with the display of the Collectanea Copyrights.

5. Pursuant to 17 U.S.C. § 504, Collectanea is awarded statutory damages from each of the Defaulting Defendants in the amount of \$150,000 for willful use of displaying the Collectanea Copyrights on display through at least the Defendant Internet Stores. This award shall apply to each distinct Defaulting Defendant only once, even if they are listed under multiple different aliases in the Complaint and Schedule A.
6. Any Third Party Providers holding funds for Defaulting Defendants, including PayPal, Inc. (“PayPal”), Alipay, Alibaba, LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. (“LianLian”), Payoneer, Stripe, Pingpong and Amazon Pay, shall, within seven (7) calendar days of receipt of this Order, permanently restrain and enjoin any accounts connected to Defaulting Defendants or the Defendant Internet Stores from transferring or disposing of any funds (up to the statutory damages awarded in Paragraph 5 above) or other of Defaulting Defendants’ assets.
7. All monies (up to the amount of the statutory damages awarded in Paragraph 5 above) currently restrained in Defaulting Defendants’ financial accounts, including monies held by Third Party Providers such as PayPal, Inc. (“PayPal”), Alipay, Alibaba, LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. (“LianLian”), Payoneer, Stripe, Pingpong and Amazon Pay, are hereby released to Collectanea as partial payment of the above-identified damages, and Third Party Providers, including PayPal, Inc. (“PayPal”), Alipay, Alibaba, LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. (“LianLian”), Payoneer, Stripe, Pingpong and Amazon Pay, are ordered to release to Collectanea the amounts from Defaulting Defendants’ financial accounts within fourteen (14) calendar days of receipt of this Order.

8. Until Collectanea has recovered full payment of monies owed to it by any Defaulting Defendant, Collectanea shall have the ongoing authority to commence supplemental proceedings under Federal Rule of Civil Procedure 69.
9. In the event that Collectanea identifies any additional online marketplace accounts or financial accounts owned by Defaulting Defendants, Collectanea may send notice of any supplemental proceeding, including a citation to discover assets, to Defaulting Defendants by e-mail at the e-mail addresses identified in Exhibit [3] to the Declaration of Yu Chung Ting and any e-mail addresses provided for Defaulting Defendants by third parties.
10. To obtain release of the bond previously posted in this action, Plaintiff's counsel must file a motion for the return of the bond once the preliminary injunction no longer applies to any Defendant.

This is a Default Judgment.
